FREQUENTLY ASKED QUESTIONS

<u>11/13/2017</u> My spouse and I both work for UAF in benefits-eligible positions but my spouse covered on my health insurance plan. Can my spouse go to the Health Center and get the SmartCAre discount.?

Yes. As long as your spouse is a benefits-eligible employee, he/she can go to the health center and qualify for the SmartCare discount, even if he/she is covered on your plan.

<u>11/6/2017</u> Do I have to enroll in the Health Savings Plan to participate in the Health Savings <u>Account?</u>

Yes, enrollment in the Health Savings Plan is required for you to enroll in the Health Savings Account. If you are enrolled in the Classic Plan, the Premier Plan or not enrolled in UA health coverage you will be eligible for a healthcare Flexible Spending Account.

<u>11/6/2017 I'm on UA health insurance now, do I need to enroll again?</u>

No. If you are on the Classic Plan, your enrollment will continue into 2018. If you are on the Point of Service Plan, which is ending 12/31/2017, you will be transferred to the Classic Plan with no action on your part. You only have to complete the enrollment process if you want to change to either the Health Savings Plan or the Premier Plan or if you want to cancel coverage.

<u>11/6/2017</u> Do I have to enroll in Flexible Spending each year?

Yes. Annual Enrollment in Flexible Spending Accounts (Healthcare Reimbursement and Dependent Care Reimbursement) is required.

<u>11/6/2017</u> Can I participate in the Dependent Care Flexible Spending Account if I participate in the Health Savings Plan?

Yes. You can still participate in the Dependent Care Flexible Spending Account if you are participating in the Health Savings Account.

<u>11/6/2017</u> Are the UMR fee schedules and provider networks the same for all three plans? Yes.

<u>11/6/2017</u> If I enroll in the Health Savings Plan and the Health Savings Account in 2018 and then switch back to Classic in 2019, will I lose my remaining HSA account?

No. You will not be able to make any new contributions to the HSA but you will keep your balance and can continue to use that to cover your unreimbursed health, dental and vision care expenses.

11/6/2017 How can I get the wellness discount?

Employees who participate in the UA health plan are invited to participate in the wellness plan. Employees who take the online Health Assessment and participate in a Health Screening between 7/1 and 9/30 can get a wellness discount or credit on their health plan for the next calendar year. New employees are given the wellness discount for the rest of the calendar year in which they are hired. Additionally, new employees whose benefits start 8/1 through 12/1 will receive the wellness discount for the year in which they are hired and for the next calendar year.

11/6/2017 Will I the UA continue to contribute to the Health Savings Account after 2018?

This is unknown at this time.
